



TERMS AND CONDITIONS FOR TICKET PURCHASING BY DEPOSIT SCHEME

Weekend Tickets (camping and non-camping) and Camping Plus upgrades can be bought using a Deposit Ticket Scheme (DTS) that allows tickets to be paid for in 5 payments (each an instalment). The 5 part DTS is available for any customer buying a ticket between 25/11/21 09:00 and 17/12/2021 23:59. The initial deposit must be made within these times.

1. The full price of your purchase will be charged as follows:

PRICE LEVEL 1	2ND (non-refundable)	£17.00 / £22.00	60 days after purchase
PRICE LEVEL 1	3RD (non-refundable)	£17.00 / £22.00	90 days after purchase
PRICE LEVEL 1	4TH (non-refundable)	£17.00 / £22.00	120 days after purchase
PRICE LEVEL 1	5TH (non-refundable)	£17.00 / £22.00	150 days after purchase

2. All instalments are non-refundable and no claim can be made to recover this money in any whatsoever other than in accordance with clause 5 of Forbidden Forests terms of entry. The first instalment will have additional booking fee and payment plan fee added on top of this, which is also non-refundable. For example for a weekend camping ticket under the 5 part payment scheme will work out at £42.50 in total (£21.00 deposit + £14.29 BF and £7.21 Payment plan fee).

3. The first instalment will be charged to your credit card or debit card immediately. Further instalments will be automatically charged to your credit card or debit card on or around the above due dates, without further recourse to you.

4. A per transaction cost of delivery of the ticket will be added to, and paid for at the time of the first instalment.

5. The transaction will be completed only once your payment of all instalments have been processed. If your debit/credit card is declined for any reason, all instalments (inc. booking fee) and your ticket reservation may be forfeited.

6. If you do not pay any of the instalments in full by the dates set out in the paragraph 1 above, you will lose (i) all instalments paid (inc. booking fee) and (ii) the ticket(s) to which you were entitled under the DTS.

- 7.) The DTS requires that a full commitment is made to purchase a ticket and pay the full ticket price plus booking fee and delivery cost when the deposit is made.
- 8.) It is recommended that you ensure funds are in place to process the payment of instalments on the dates set out in paragraph 1 above.
- 9.) These special Terms and Conditions are in addition to the standard Terms and Conditions for Festickets.
